#### VIII. - Operations

**OP 1** Status Update on the Lateral Extension

- Robert Sheets, GSG: we have received an estimate; this is a non-binding estimate for the cost of the laterals. There are two laterals- Water and Wastewater. How do we serve the new customer for water and sewer
- This will serve the new customer per water and sewer. The quotes for both lines are around \$36,000 each (72,000). If we could do both lines simultaneously, there would be some cost reductions.
- Mr. Sheets sugged to put it out for bid. Mr. Sheets stated not to bid because of the size of the
  machine that is needed to bore horizontally under Highway 79. The company needs the capacity
  to do the job; a local firm in Washington County does this kind of service and has the machine
  and the capacity to do the job.
- The board has a couple of options: issue an RFP/Bid
- The board could authorize the staff/GSG to get three (3) quotes

- We would enter into a reimbursement agreement with the original developer and pay for the cost upfront to get the services.
- The GSG staff will meet with the original developer to discuss the agreement and bring it back to the board at the next meeting
- we would work out in agreement with the original developer that as other connections came on, the capacity fees that we would charge them to reimburse us for our costs or the line, those capacity fees would be paid to the original developer in a 10-year time frame, the developer will be reimbursed for his upfront cost for these services
- Robert Sheets, GSG, and Evan Rosenthal, NGN: will meet with the developer to discuss the price rates and scope of services with the developer
- Chairman Hawkins, Washington County: The question for the board do we want to set our
  procurement policy aside and have Mr. Sheets and his staff get the three quotes to install the
  water and sewer lines under Highway 79 for the lateral
- Mr. Sheets and the staff will meet with the developer and negotiate with the developer their proposal and our approach and back to the board at the next meeting.
- Evan Rosenthal, NGN, it's 20,000 for the authority. You can waive the procurement policy here, and if you want to waive it and direct, as Robert and his staff, to reach out to at least three firms for quotes
- Robert Sheets and his staff to reach out to at least three firms for quotes
- Chairman Hawkins: the motion would be that we need three (3) quotes from interest firms to install the water lines.
- Working with the developer to work out an agreement for the payment for the proposed line
- We need a quote from Melvin Engineering for Construction Engineering Inspection (CEI). The contract will be brought back to the next board meeting for approval.
- Mr. Ryan Martin, City of Bonifay: Waive the procurement policy, and get at least three(3) quotes; negotiate a contract with Dr. Hawkins (developer). He will pay for these water lines, and we will pay him back.
- Chairman Hawkins: overtime the future, connections will pay Dr. Hawkins back
- Mr. Ryan Martin: I move for the motion pending Dr. Hawkins's acceptance
- Evan Rosenthal: we need direction on doing water and wastewater. We can only require Dr. Hawkins to pay for the wastewater.
- Do you want to move forward with doing water and wastewater now?
- There needs to be a workshop in the next 30-60 days with your grants consulting to discuss and apply for grants to cover the cost of the laterals
- The cost saving to install both lines, the water, and the wastewater, would be 4,000-6.000; we have paid for the pipe this cost is for the installation only.
- Chairman Hawkins: What is your recommendation to install the sewer and work with our grants team to install the water later?
- Jeff Good: I'll second based on the attorney's recommendation.
- Evan Rosenthal: the recommendation would be to do just wastewater. Yes

 Chairman Hawkins, Washington County: Mr. Sheets to bring back and find out the mobilization fees for next month. If we, if there's going to be huge cost savings to move them both forward at the same time. And, this plan for a workshop in the upcoming future with all of our boards so we can discuss.

- Evan Rosenthal, NGN: We readvertised the RFP for Board Clerk Services and the Management Services. We issued an RFP/bid for the Board Clerk and Financial Management services. These functions are currently provided under the general manager contract with GSG
- We readvertised the RFP for Board Clerk Services, with an extension date of January 31 per the board's direction at the last board meeting.
- We received one response, which is from the city of Bonifay. They have proposed to provide board clerk services for \$15,000 per year.
- Evan Rosenthal We are seeking board direction
- Robert Sheets: You have several options: you can defer for further discussion at a workshop, or you could have the city make a presentation to the board
- Chairman Hawkins: I want to discuss this at a future workshop. There is a huge difference between going monthly to a quarterly meeting for the custodian of records. We need to work out the fee if the board is going to a quarterly meeting with the City
- Ryan Martin: I motion to accept the city of Bonifay's proposal
- Chairman Hawkins: The board may do quarterly meetings that may not have been part of the city of Bonifay's proposal.
